RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO AN INTERCONNECTION OPERATION AGREEMENT WITH THE BRISTOL COUNTY WATER AUTHORITY

WHEREAS, the Bristol County Water Authority ("BCWA") and the City of East Providence both rely on the Providence Water Supply Board to supply water to their respective customers; and

WHEREAS, the City obtains its water from Providence through twin 32" pipes identified as the Cross Bay Pipeline; and

WHEREAS, the BCWA obtains its water from Providence through an 18" pipe identified as the East Bay Pipeline; and

WHEREAS, the BCWA, the City, and their respective customers would be adversely impacted should there be a disruption in the water supply from Providence as the BCWA and the City do not have adequate backup water supplies; and

WHEREAS, the BCWA has constructed a pumping station located on Pawtucket Avenue which is to be transferred to the City; and

WHEREAS, the BCWA has installed a 16" interconnection to the City's water system at the pumping station and constructed a 24" interconnection between the BCWA water system at the Silver Spring Golf Course and the existing City system at the Kent Heights tank site; and

WHEREAS, the BCWA and the City are desirous of entering into an agreement for the operation of the pumping station, the 16" interconnection and the 24" interconnection to ensure that their use does not interfere with the operations of either system concerning pressure, flow and water quality.

NOW, THEREFORE, BE IT RESOLVED, that the City Council of the City of East Providence hereby authorizes the Mayor to enter into an Interconnection Operation Agreement with the Bristol County Water Authority.

RESOLUTION IN SUPPORT OF OPERATION ZAP AND ENCOURAGING EAST PROVIDENCE RESIDENTS TO JOIN THE 50TH ANNIVERSARY OF OPERATION ZAP

WHEREAS, Operation ZAP was organized in 1972; and

WHEREAS, Operation ZAP began the environmental movement in the Blackstone River Valley; and

WHEREAS, the Blackstone River became the first industrialized river and first polluted riverway in the Western Hemisphere; and

WHEREAS, Samuel Slater, on the Blackstone River in 1790, launched the American Industrial Revolution, and initiated economic freedom for the United States; and

WHEREAS, the use of the Blackstone River's waterpower offered the strength needed to power hundreds of textile mills along its 48 mile length; and

WHEREAS, these mills employed thousands of people that arrived from all over the world in search of their American Dream; and

WHEREAS, while this economic opportunity catapulted the Blackstone Valley businesses into a world economy for almost 200 years, it also left a legacy of environmental degradation; and

WHEREAS, this environmental condition has denied ten generations the use of the Blackstone River for drinking, swimming or eating its aquatic life; and

WHEREAS, the landscape along the Blackstone River has taken over five decades to attempt to bring back to health; and

WHEREAS, the mission of *Operation ZAP* in 1972 was to clean the Blackstone River making it possible for future generations to enjoy living along a clean river way; and

WHEREAS, Operation ZAP coincided with the founding of Earth Day and in the United States Congress' passage of the Clean Air and Clean Water Acts, and the founding of Save the Bay, which is dedicated to protecting and improving our Narragansett Bay and all the waters that flow into it; and

WHEREAS, Operation ZAP was conceived and organized by David M. Rosser of Pawtucket, Rhode Island, the then President of the Blackstone River Watershed Association; and

WHEREAS, on September 9, 1972 Mr. Rosser, with the help of hundreds of community leaders and businesses, organized more than 10,000 people to remove tons of refuse from the banks of the Blackstone River and begin the creation of riverfront parks; and

WHEREAS, since that time the Blackstone River has seen millions of dollars of federal, state and local money spent on continuing the clean-up efforts; and

WHEREAS, since that time the Blackstone River has become cleaner for fish and wildlife; and

WHEREAS, the *Blackstone Valley Tourism Council* is organizing an effort, with dozens of local volunteer groups and individuals, with the goal of organizing 10,001 people, to celebrate the people and groups that have helped clean the Blackstone River; and

WHEREAS, dozens of people have worked to develop a Blackstone River Watershed Needs Assessment that points to a future where residents will be able to eat the fish, drink the water and swim in the Blackstone River; and

WHEREAS, it is time to be a part of this environmental movement, this time Blackstone River Watershed-wide, to clean up and green up the 25 Blackstone River Watershed communities from Worcester, Massachusetts to Providence, Rhode Island; and

WHEREAS, the David Rosser family is working with the local organizers of ZAP50 to insure the environmental legacy is continued; and

WHEREAS, this will be a time to celebrate the people who worked on *Operation ZAP* in 1972 and the organizations and people who continue the work to bring the Blackstone River back to health.

NOW, THEREFORE, BE IT RESOLVED, that the City of East Providence joins ZAP 50, to be with the 10,001 people that will assemble on August 27, 2022 to clean the Watershed and will assemble again on September 10, 2022 at the Old Slater Mill National Historic Site in Pawtucket, the base camp of Dave Rosser's headquarters for Operation ZAP in 1972 to celebrate.

BE IT FURTHER RESOLVED, that the City of East Providence commits its leadership, necessary resources, and participation to assist in mobilizing its citizens to "turn out" to join the 50th Anniversary of Operation ZAP. We call upon all to honor the work performed in 1972, honor the groups and agencies for the past and current ongoing efforts, and ensure that the Operation ZAP of 1972 goals are realized.

CHAPTER

AN ORDINANCE IN AMENDMENT OF CHAPTER 9 OF THE REVISED ORDINANCES OF THE CITY OF EAST PROVIDENCE, RHODE ISLAND, 1998, AS AMENDED, ENTITLED "MISCELLANEOUS OFFENSES"

THE COUNCIL OF THE CITY OF EAST PROVIDENCE HEREBY ORDAINS:

SECTION I. Subsection (a)(1) of Sec. 9-13 entitled "Sale of cigarettes by vending machine prohibited" of Chapter 9 of the Revised Ordinances of the City of East Providence, Rhode Island, 1998, as amended, entitled "Miscellaneous Offenses" is amended to read as follows:

Sec. 9-13. Sale of cigarettes by vending machine prohibited.

- (a) No person, firm, corporation, establishment or agency shall engage in the operation of selling cigarettes by vending machine provided, however, that this section shall not apply to:
 - (1) Cigarette vending machines in establishments where, as a condition of entry to the premises and access to the cigarette vending machine, persons are required to be at least 18 21 years of age; or

SECTION II. Section 9-15 entitled "Purchase, sale or delivery of tobacco products to persons under 18 prohibited; notice of law to be posted" of Chapter 9 of the Revised Ordinances of the City of East Providence, Rhode Island, 1998, as amended, entitled "Miscellaneous Offenses" is amended to read as follows:

Sec. 9-15. Purchase, sale or delivery of tobacco products to persons under 18 21 prohibited; notice of law to be posted.

- (a) No person, or employee or agent of such person, shall sell or possess with the intention of selling, under 18 years of age shall purchase nor shall any person sell, give or deliver to any person under 18 21 years of age any tobacco products in the form of cigarettes, cigars, pipe tobacco, chewing tobacco, or snuff, electronic cigarettes or other forms of electronic nicotine delivery devices (ENDS).
- (b) Any person, firm or corporation that owns, manages or operates a place of business in which tobacco products are sold including sales through cigarette vending machines, shall post notice of this law conspicuously in such place of business in letters at least three-eighths of an inch high. Signs required by this section may be provided by the department of health at cost.
- (c) Sale of flavored tobacco products prohibited. No licensee, or employee or agent of such licensee, shall sell any flavored tobacco product to a consumer. A non-cigarette tobacco

product is presumed to be a flavored tobacco product if a manufacturer or any of the manufacturer's agents or employees has:

- (1) made a public statement or claim that the non-cigarette tobacco product has or produces a characterizing flavor, including, but not limited to, text and/or images on the product's labeling or packaging that are used to explicitly or implicitly communicate information about the flavor, taste, or aroma of a non-cigarette tobacco product; or
- (2) taken action directed to consumers that would be reasonably expected to result in consumers believing that the non-cigarette tobacco product imparts a characterizing flavor. Each licensee shall maintain on the premises the original labeling and packaging provided by the manufacturer for all tobacco products that are sold or offered for sale by the licensee separately from the original packaging designed for retail sale to the consumer. The original labeling and packaging from which the contents are sold separately shall be maintained during such time as the contents of the package are offered for sale, and may be disposed of upon the sale of the entire contents of such package. Flavor is characterized by a distinguishable taste or aroma, other than the taste or aroma of tobacco, menthol. minter or wintergreen, imparted either prior to or during consumption of a tobacco product or component thereof, including, but not limited to, tastes or aromas relating to any fruit, chocolate, vanilla, honey, candy, cocoa, dessert, alcoholic beverages, her, or spice; provided, however, that no tobacco product shall be determined to have charactering flavor solely because of the use of additives of flavorings or the provision of ingredient information.

This subsection (c) shall not apply to a smoking bar as defined in Section 23-20.10-2(15) of the Rhode Island General Laws.

"Tobacco product" does not include a product that has been approved by the United States Food and Drug Administration for sales as a tobacco cessation product or for other therapeutic purposes where the product is marketed and sold solely for such an approved purpose.

- (e)(d) Any person violating the provisions of this section shall be penalized as follows:
 - (1) Such person shall be fined \$200.00; \$250.00;
 - (2) Any person violating this section a second time within 36 months of the first offense shall be fined \$300.00; \$350.00;
 - (3) Any person violating this section a third time within 36 months of the first offense shall be fined \$500.00 and may be ordered not to sell tobacco products for up to 90 days.
 - (4) Any person violating this section may be ordered to complete tobacco retailer training as deemed appropriate by the local substance abuse task force (East Providence Prevention Coalition).
- (d)(e) Any person violating this section shall be cited for such violation and may:
 - (1) Pay the fine indicated on the citation either by mail or in person, within 20 days after receiving the citation; or
 - (2) Shall be required to appear in the Municipal Court for the City of East Providence for a hearing on that citation.

(f) All fines collected by municipal court or the East Providence City Council sitting as the licensing commission hereunder shall be paid to the City of East Providence. It is the intent of this legislation that all fines collected by the City of East Providence hereunder shall be used for the purpose of the East Providence Police Department conducting tobacco produce compliance checks and the East Providence Prevention Coalition providing tobacco education.

SECTION III. This ordinance shall take effect upon its second passage and all ordinances or parts of ordinances inconsistent herewith are hereby repealed.

CITY OF EAST PROVIDENCE

CHAPTER

AN ORDINANCE IN AMENDMENT OF CHAPTER 13 OF THE REVISED ORDINANCES OF THE CITY OF EAST PROVIDENCE, RHODE ISLAND, 1998, AS AMENDED, ENTITLED "PUBLIC PLACES"

THE COUNCIL OF THE CITY OF EAST PROVIDENCE HEREBY ORDAINS:

SECTION I. Subsection (a) of Section 13-4 entitled "Smoking at public places" of Article I entitled "In General" of Chapter 13 of the Revised Ordinances of the City of East Providence, Rhode Island, 1998, as amended, entitled "Public Places" is amended to read as follows:

Sec. 13-4. Smoking at public places.

(a) Since smoking is a public nuisance and dangerous to public health, it shall be unlawful for any person to smoke in any form or otherwise use tobacco products, including electronic cigarettes, or other forms of electronic nicotine delivery devices (ENDS), or the use of combustible cannabis, in any public buildings, public parks or any other indoor or outdoor recreational areas or facilities owned by the city or leased by the city as lessee, and in all motor vehicles of any type or kind owned, rented, leased or used by the city or any of its departments, boards, or commissions.

SECTION II. This ordinance shall take effect upon its second passage and all ordinances or parts of ordinances inconsistent herewith are hereby repealed.
