




03/25/2024 LOWER LEVEL DEMOLITION PLAN EAST PROVIDENCE PD EXISTING RENOVATIONS







# RESOLUTION AUTHORIZING THE GRANTING OF A TEMPORARY CONSTRUCTION EASEMENT OVER AN ADDITIONAL PORTION OF LAND OWNED BY THE CITY AT SILVER SPRING PLAYGROUND

WHEREAS, the City is the owner of a parcel of land known as Silver Spring Playground, Assessor's Map 16, Lot 1; and

WHEREAS, the Narragansett Electric Company desires to utilize an additional portion of the property as a temporary construction area in order to facilitate construction activities in support of its gas line replacement project; and

WHEREAS, the Narragansett Electric Company also seeks to abandon a prior granted easement and extend it to a new location as noted in Exhibit A attached hereto; and

WHEREAS, Rhode Island General Laws §45-2-4 empowers the City Council to grant interest in property.

## NOW, THEREFORE BE IT RESOLVED,

- (1) The City Council of the City of East Providence authorizes the granting of a temporary construction easement and the relocation of a prior granted easement over an additional portion of land owned by the City at Silver Spring Playground.
- (2) The Mayor, by and through the office of the City Solicitor, is hereby empowered to take all necessary steps to grant and perfect a temporary construction easement over an additional portion of land owned by the City at Silver Spring Playground as set forth in the Agreement and as depicted on Exhibit A attached hereto.

## **AGREEMENT**

THIS AGREEMENT (this "Agreement") is made as of this \_\_\_\_\_day of \_\_\_\_\_\_\_, 202\_\_, by and between the CITY OF EAST PROVIDENCE a municipal corporation organized under the laws of the State of Rhode Island with a usual place of business at 145 Taunton Avenue, East Providence, RI 02914 ("EPRO"), and THE NARRAGANSETT ELECTRIC COMPANY, a Rhode Island corporation having a usual place of business at 280 Melrose Street, Providence, Rhode Island 02907 ("TNEC").

WHEREAS, TNEC is the owner of certain perpetual rights and easements in, over, across, under, through and upon certain land in East Providence, Rhode Island situated easterly of Dodge Street (hereinafter referred to as the "TNEC Easement") for the purposes of constructing, repairing, maintaining, operating and patrolling its natural gas distribution facilities, together with the right to pass and repass over the Property (as hereinafter defined) as reasonably required in order to access the TNEC Easement; and

WHEREAS, EPRO is the owner of certain land in East Providence, Rhode Island identified as East Providence Assessor's Map 16 Lot 1 (the "Property"); and

WHEREAS, in order for TNEC to facilitate construction activities in support of its gas line replacement project, TNEC desires to utilize an additional portion of the Property as a temporary construction area.

NOW, THEREFORE, in consideration of the mutual covenants hereinafter recited and other good and valuable consideration, the sufficiency of which is hereby acknowledged, under seal, the parties agree as follows:

- (1) <u>Grant of License</u>. EPRO hereby grants TNEC, and its authorized agents, employees, representatives and contractors, a license to enter and use a portion of the Property in the location shown on the plan attached hereto as Exhibit A and made a part hereof, as a temporary construction area.
- (2) Term. The license granted herein shall commence July 1<sup>st</sup>, 2024, and continue for a period of six (6) weeks. TNEC shall have two options to extend the license for periods of one (1) week each. If TNEC desires to exercise this option, it must notify EPRO, in writing, no later than five (5) days prior to the expiration of this license. In the event the option is exercised, the terms and conditions as stated herein shall apply.
- (3) <u>Safety and Compliance</u>. Any contractor engaged by TNEC to perform the Activity at the Property in connection with this Agreement shall be responsible for the protection of the health, welfare and safety of all persons and property during the performance of the Activity and compliance with applicable federal, state and local governmental laws, ordinances, codes, rules and regulations.
- (4) <u>Indemnification: Insurance.</u> TNEC agrees to indemnify, hold harmless and defend EPRO from and against all injury, loss, or damage (including death) on or about the Property caused by or resulting from the negligence or willful misconduct of TNEC or its agents, employees, representatives, or contractors in connection with or arising out of the performance of the Activity at the Property; provided, however, that TNEC shall not be responsible for the negligence or willful misconduct of EPRO, or their agents, employees, representatives, or contractors at the Property. TNEC further agrees that it shall maintain comprehensive general liability insurance in terms and amounts commercially reasonable covering any action arising in connection with the Activity and shall include EPRO as additional insureds thereunder.

- (5) Restoration of Property. TNEC agrees that, upon completion of the Activity, TNEC shall repair any damage to the Property caused as a result of the Activity, to restore the ground surface of the Property to substantially the same condition in which it existed prior to TNEC's commencement of the Activity, including seeding the Property with similar grass and/or vegetation. TNEC's restoration obligations under this Paragraph shall survive any termination of this Agreement.
- (6) <u>Site Security</u>. TNEC agrees that during active construction activities on the Property, the construction area will be secured with temporary fencing during the Term.
- (7) Transfer or Sale of Property; Binding Effect. During the Term of this Agreement, EPRO shall notify TNEC in advance as promptly as practicable of the proposed transfer or sale of all or any part of the Property. This Agreement shall be binding upon and inure to the benefit of the parties hereto and their respective successors, including successors in title to the Property. This Agreement is solely for the benefit of said parties and their respective successors and assigns and may not be enforced by, nor shall it be construed for the benefit of, any third party.
- Miscellaneous. This Agreement shall be governed by and construed in accordance with the laws of the State of Rhode Island. This Agreement may not be modified or amended unless mutually agreed upon in writing by both parties. If any term, provision, covenant, or condition of this Agreement is held by a court of competent jurisdiction to be invalid, void or unenforceable, the rest of this Agreement shall remain in full force and effect and shall in no way be affected, impaired or invalidated. This Agreement may be executed in multiple counterparts, each of which shall have the force and effect of an original and all of which together shall constitute but one and the same document. A signature sent by facsimile or as a.pdf by email shall have the same force as an original signature.
- (9) <u>Due Authority</u>. EPRO represents to TNEC that the execution of this Agreement has been duly authorized by EPRO, that the person signing this Agreement has the authority to sign on EPRO's behalf and to thereby bind EPRO to the same, and that the signature of no other party is required. TNEC represents to EPRO that the execution of this Agreement has been duly authorized by TNEC, that the person signing this Agreement has the authority to sign on TNEC's behalf and to thereby bind TNEC to the same, and that the signature of no other party is required.





INTEROFFICE MEMORANDUM

To: Mayor Roberto DaSilva

**RE: 2024 TAX SALE PROCESS** 

Per your request I put together this memo to summarize the steps taken by the Tax Collector's Office to prepare for the 2024 Tax Sale. The 2024 tax sale with be held on April 17, 2024.

- The City of East Providence last held a tax sale on October 27, 2020, due to the pandemic there hasn't been a tax sale since.
- The City of East Providence ran a one-time tax amnesty period from August 15, 2023, to October 14, 2023, that gave taxpayers the opportunity to have their interest waived on any outstanding taxes owed on their 2022 bills or prior.
- On December 8, 2023, the Tax Collector's Office mailed out 1170 water reminder/warning letters and 208 real estate reminder/warning letters to property owners with past due balances that qualified them for tax sale with a due date of January 10, 2024. It was at this time that the Tax Collector's Office made payment plan arrangements for the properties that are owner occupied (receiving the homestead exemption).
- Between the dates of January 3, 2024, and March 7, 2024, the Tax Collector's Office entered into 82 water payment plan arrangements and 9 real estate payment plan arrangements.
- On January 18, 2024, the **Law Offices of Glenn J. Andreoni, Inc.** mailed out 90-day letters in accordance with tax sale law RIGL 44-9.
- On March 8, 2024, the **Law Offices of Glenn J. Andreoni, Inc.** mailed out 40-day certified mail letters in accordance with tax sale law RIGL 44-9. It was at this time payment plan arrangements were no longer being made.
- Also, on March 8, 2024, the list of properties that received the 40-day letter was emailed to Rhode Island Housing. Rhode Island Housing by law has the right to first refusal of all properties going to tax sale.
- There were 276 properties that were mailed the 40-day certified mail letters.

- As of today April 11, 2024, there are 62 properties remaining on the tax sale list.
- Within the remaining 62 properties the following 4 are receiving the widow of a veteran exemption.

  - 62 Fenner Avenue
  - 39 Glen Street
  - 88 Allen Avenue




