**REQUESTING THE GOVERNOR AND THE RHODE ISLAND GENERAL ASSEMBLY  
TO ALLOCATE \$8 MILLION OF THE NEW STIMULUS MONEY TO  
AFTERSCHOOL AND SUMMER PROGRAMS**

***WHEREAS***, due to the COVID-19 public health crisis, the State of Rhode Island has enacted a number of executive orders and health directives that has negatively impacted Rhode Island Afterschool and Summer Programs; and

***WHEREAS***, Rhode Island Afterschool and Summer Programs are comprised of educational professionals, out-of-school time providers, youth, and their families that work together to provide opportunities, social emotional learning, and safe spaces for thousands of Rhode Islanders including in East Providence, Rhode Island; and

***WHEREAS***, while well-intentioned, some directives, mandates, and executive orders have left youth and their families without access to Afterschool and Summer Programs here in Rhode Island during the pandemic, including 58,000 youth trying to get into programs throughout the state; and

***WHEREAS***, dollars directed to the Rhode Island Department of Education and the Department of Human Services from the CARES Act have not been flexible for Afterschool and Summer Programs to remain open and accessible to youth and their families, with such programs having to adjust space, lay-off staff, and not serve to full capacity to keep their doors open, or qualify for any dollars from the CARES Act stimulus money due to state agency regulations; and

***WHEREAS***, for every 1 youth in Rhode Island in an Afterschool and Summer Program there are 3 youth waiting to get in despite the CARES Act dollars being allocated to said state agencies that serve school aged youth;

***NOW, THEREFORE, BE IT RESOLVED***, that the East Providence City Council strongly urges both the Governor and the General Assembly to act without delay to allocate \$8 Million from one or more of the following stimulus funding sources: Governors Emergency Education Relief Fund, Elementary and Secondary School Emergency Relief Fund (ESSER II) K-12 funds, the \$23.5 Million Child Care funds, and Coronavirus Relief Fund for states and counties, to Afterschool and Summer Programs serving Rhode Island youth.

***BE IT FURTHER RESOLVED***, if the State of Rhode is unable to provide said request, we urge immediate and decisive action to be taken by state leaders to provide significant additional financial assistance to Afterschool and Summer Programs that are struggling and negatively impacted by the pandemic and economic crisis, for the sake of youth, working families, organizations, professionals, providers, and the community.

***BE IT FURTHER RESOLVED***, that a copy of this resolution be forwarded by the City Clerk to the Honorable Governor Gina M. Raimondo, to all of the Honorable Representatives and Senators representing the City of East Providence in the General Assembly, to the Honorable Rhode Island Speaker of the House and Rhode Island Senate President, and to all Rhode Island city and town councils, who are respectfully urged to also pass this resolution in support of Afterschool and Summer Programs in their communities.

**RESOLUTION SEEKING GENERAL ASSEMBLY APPROVAL TO ENTER  
INTO A TEN YEAR TAX TREATY WITH EXXON MOBIL OIL CORPORATION  
PURSUANT TO A PRIOR SETTLEMENT AGREEMENT**

**WHEREAS**, the City and ExxonMobil Oil Corporation previously entered into a Settlement Agreement dated December 31, 2020 regarding the assessment of taxes on certain parcels of land in the City of East Providence owned by ExxonMobil Oil Corporation; and

**WHEREAS**, said agreement requires both parties to support legislation allowing them to enter into a ten-year tax treaty; and

**WHEREAS**, legislation enabling the City to carry out the terms of the Settlement Agreement has been introduced in the General Assembly.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of East Providence hereby supports the legislation to enter into a ten-year tax treaty with Exxon Mobil Oil Corporation and respectfully requests that the Rhode Island General Assembly enact the bill into law.

**NOW, THEREFORE, BE IT FURTHER RESOLVED** that the City Clerk send a copy of this Resolution to the Governor of the State of Rhode Island, the Lieutenant Governor of the State of Rhode Island, the President of the Rhode Island Senate, the Speaker of the Rhode Island House of Representatives and the Senators and Representatives from the City of East Providence.

CHAPTER

AN ORDINANCE IN AMENDMENT OF CHAPTER 8 OF THE  
REVISED ORDINANCES OF THE CITY OF EAST PROVIDENCE,  
RHODE ISLAND, 1998, AS AMENDED, ENTITLED  
“LICENSES AND BUSINESS REGULATIONS”

THE COUNCIL OF THE CITY OF EAST PROVIDENCE HEREBY ORDAINS:

**SECTION I.** Sec. 8-35 entitled “Underground utility contractors—Permit” of Article II entitled “Miscellaneous Business and Occupational Licenses and Permits” of Chapter 8 of the Revised Ordinances of the City of East Providence, Rhode Island, 1998, as amended, entitled “Licenses and Business Regulations” is amended to read as follows:

Sec. 8-35. Underground utility contractors—Permit.

No person shall engage in the business of underground utility contractor unless said person has a license from the State of Rhode Island as defined under G.L Ch. 5-65.5 et seq. No person shall engage in the installation, maintenance and repair of underground utility systems within the City of East Providence without first obtaining a permit for ~~said~~ each installation ~~and~~ or repair from the director of public works and payment of all fees associated with said permit. The director of public works shall only issue an underground utility contractor permit for work to be performed on public rights of way and/or roadways under the following circumstances:

(1) Minor Disturbance. If the work to be performed shall disturb less than one hundred square feet (100sqft) of public right of way and/or roadway:

a. The required repair and sealing of the public right of way and/or roadway shall be in the discretion of the Director of Public Works and such requirements may be included on the permit upon issuance.

(2) Major Disturbance. If the work to be performed shall disturb at least one hundred square feet (100sqft) of public right of way and/or roadway:

a. And the disturbed area was paved within the previous five (5) years, then issuance of such a permit shall require replacement of the public right of way and/or roadway edge to edge along the entire length of the disturbance.

b. And the disturbed area was paved between five (5) and fifteen (15) years ago, the disturbed area shall be repaved in the following manner:

i. On roadways less than twenty-four feet wide (24') edge to edge repaving required unless the director of public works specifies



- that the repair should performed edge to centerline of roadway with either crack sealant or infrared heat treatment of the resulting seam.
- ii. On roadways at least twenty-four feet wide (24') the repair should performed edge to centerline of roadway, and the resulting seam shall employ either crack sealant or infrared heat treatment as may be determined by the director of public works.
  - c. And the disturbed area was paved more than fifteen (15) years ago, the disturbed area shall be repaved in the manner the director of public works deems appropriate.

(3) Compliance and Enforcement.

- a. No permit shall be issued to any applicant who has performed any work that is not fully compliant with the provisions herein unless and until that previous work is brought into compliance with this section to the satisfaction of the director of public works.
- b. No permit shall be issued to any applicant who has outstanding fines or fees due and owing to the City of East Providence.
- c. Failure to comply with this section shall incur a five-hundred-dollar (\$500.00) per day fine for each day that the roadway or public right of way is not appropriately repaved as shall be determined by the Department of Public Works.
  - i. If, in the discretion of the Department of Public Works, the City must perform any work to ameliorate problems related to a failure to comply with this section, the cost of such work must be repaid before any future permit is issued to the violator.
  - ii. Any funds derived from enforcement of this section shall be set aside in a fund limited for use to support public roadway repair, including but not limited to sidewalk repairs, maintenance of manholes and catch basins such that such infrastructure remains flush with roadways, curbing and patching.

**SECTION II.** This ordinance shall take effect upon its second passage and all ordinances or parts of ordinances inconsistent herewith are hereby repealed.

SECTION III. As of the advertisement of this Ordinance, there is an unencumbered and unallocated balance of funds remaining in the Capital Budget in an amount equal to: **\$6,155,440.**

SECTION IV. The purpose of this Ordinance is to allocate **One Hundred and Fifty Thousand Dollars (\$150,000)** of the remaining unencumbered and unallocated Capital Budget to the **Carousel** following Capital Project:

- **Enhancements to Crescent Park and/or the Loeff Carousel and/or Facilities related and supportive thereto, including improvements such as concession or food related infrastructure or buildings**

**SECTION V.** This ordinance shall take effect upon its passage and all ordinances and parts of ordinances inconsistent herewith are hereby repealed.
