Presentation by Wainwright Investments LLC

Michael Dwyer started with the good news. It was a very strong year. The year-end report shows the pension fund up 15.12% with a total of \$165,801,224. The three and five year numbers are very healthy as well, certainly well above the actual rate of return. Domestic Equites has been very strong. Only Vangaurd Small Cap has been underperforming. In real estate/real assets Sigulaer Guff is coming to an end of it's life. With an original commitment of 4 million that only 3.7 million was called, it has already distributed 5 plus million. Mike is very happy with all the alternative investment choices made a year ago for real estate and private equity, they are really paying off in these volatile times.

What's happening now, the pension fund as of today totals \$158 and change, down 4.5%. The markets are very concerned with what the federal government is going to do. Feds are making a directional change which they haven't done in a very long time. They are defiantly going to raise interest rates in March. Drops are normal. They happen. It's normal during corrections. Mike wouldn't be surprised if the pension fund saw two or three drops of more than 5% this year. He feels the pension fund is still on course and recommends no moves at this time. They will watch and pay attention to how the world reacts to current events. It's going to be a very volatile year.

The cash position is good through next quarter unless capital calls come in. If funds are needed Mike suggested they should come from Vangaurd, Rhumline or Barrings.

A motion was made to allow Trustee Moore to work with Wainwright to rebalance where necessary when funds for payment of monthly invoices and any capital calls are needed by Trustee Neale and 2nd by Trustee Wallace

Brief update on the changeover to Principal

Trustee Neale was in discussions with a police retiree from Florida who runs a blog for approximately 20 retired members. He wanted Trustee Neale to publicly thank Kim Brown for superior work and make the Board aware of all that she has done for the retirees. She seamlessly handles countless issues, keeping things on track.

Discussion/Vote regarding editing the wording of Ordinance 11-252 originally presented as 11/253 in September 2018 titled Death of a Retired Participant

The City Solicitor stated that luckily there haven't been any deaths and he has nothing to present. Trustee Moore and the Solicitor did meet and discuss the wording but most of their time has been spent regarding the military buyback and this didn't get done. Trustee Wyrostek suggested that this be tabled to the next meeting. Trustee Mourato asked what the general intent was. The Solicitor explained that it was to take care of the spouse the participant is married to at the time of retirement. If they get divorced and remarried the new spouse would not be entitled to the survivor benefit. Trustee Nelson stated that the wording is somewhat there. The Solicitor agreed but thinks the current wording is ambiguous and needs to be clarified. Trustee Wyrostek stated that basically it's the one line that was not finished. It's the legacy of the pension, this could hurt the pension. Trustee Nelson asked what the intent was originally and the Solicitor stated that he couldn't say. Kim will send Trustee Nelson the minutes and recordings from the original meetings.

Discussion/Vote regarding a Military Buyback policy

The City Solicitor stated that had done a lot of work on this over the past three months. It's not a policy that has to be written, it's a Federal Law that needs to be followed. Trustee Moore stated that the employee has the right to buy back interest free over three times the length of time they were deployed up to a maximum of five years. Trustee Moore ran into a hiccup today that needs to be researched. If the employee returns from deployment and hasn't finished paying for the buyback and gets redeployed does the time clock stop until they get back? The Solicitor is going to check into the freeze on the repayment time line if redeployed. The Solicitor stated that there is a notification time frame that needs to be sent to someone in the City with the intent in writing I'm back and I want to buy back time. The Solicitor stated that the most important part is that interest cannot be charged. Trustee Nelson asked if the City was also responsible for putting in the employee contributions. Trustee Moore explained that the City already was putting in the correct amount based on the actuarial annual amounts to contribute it was just the employee share missing. Trustee Mourato state he had an employee where he works going through the same thing and wondered why the Board was looking into this. The Solicitor stated that is was the notification and the time bar from the first deployment, the employee has been deployed for the last eleven years. The City may put out a notice stating the steps that have to be followed by the employee on deployment.
