### Presentation by Wainwright Investments LLC

Michael Dwyer stated it's not a bad report overall but April was awful, 9.4% down. The world is in chaos and the Federal Reserve is in slow motion, possibly mistake phase. The report shows the total fund with a balance of \$159,568,232 as of March 2022. Wainwright is hoping the Federal Reserve doesn't go too far too fast, time will tell. Jeff Fabrizio stated that portfolio is down approximately 3% year to date. It's very unusually for Bonds and Equites to both be losing money. Mike stated, there will be periods of volatility, you just need to hold steady through the painful periods. Wainwright is recommending the 1 or 1.5 million be taken out of Principal to have cash on hand for any EnTrust capital calls that might come. They also suggest RhumbLine. They are not recommending touching any Hedge Funds. Vice Chair recommended maybe taking funds from another class seeing as Principal is making the Board money. Mike explained that Real Estate is over weighted so that's a good class to take it from. Trustee Moore stated that he has been asked recently that maybe the money should be taken out and parked somewhere for safe keeping. Mike explained that pension funds don't typically do that, it's very difficult to tactically move money strategically; most of the funds are tied up and are not liquid. Invesco is underperforming; their China and Russia decisions have affected the fund. Wainwright will do a search for emerging markets and report back at the next meeting to the Board to possibly replace Invesco. Wainwright passed out an updated investment policy statement for the Board to review. They would like to make some changes. At the next meeting questions can be asked and a possible vote taken.
