NARRATIVE TO DIMENSIONAL PETITION OF SAFE HARBOR PROPERTIES, LLC

SAFE HARBOR PROPERTIES, LLC owns the property located at 48 Lincoln Avenue where thirteen people live as the functional equivalent of a family. For all intents and purposes they are a family. They do not fall into the definition of a traditional family related by blood or marriage. They live together with common access to, and common use of, all living and eating areas and all areas and facilities for the preparation and storage of food within the dwelling unit. They rely upon one another for peer-to-peer interactions with each person being both a provider and a consumer.


They are all persons dealing with the diseases of alcoholism and addiction. Their disease places them in a protected class under the Federal Fair Housing Act, 42 U.S.C. 3602(h).


In this sense they are related by other legal means (they are all members of the same protected class) and live as the functional equivalent of a family.

They do this using the Social Model of Recovery. The Social Model of Recovery depends upon peer-to-peer interactions with each person being both a provider and a consumer in recovering from or dealing with the difficulties of their disease.

This petition is asking for a dimensional variance as to the number of unrelated persons living in a Household under 19-1 (2) from 4 to 13 as a reasonable accommodation as required under the Federal Fair Housing Act, 42 U.S.C. 3604(f)(3)(B). In the alternative this board can look upon them as a Family under 19-1 (1) which does not have the limitations of 19-1 (2).

We will be presenting testimony through a number of witnesses as the living process and conditions of living in the house as well as how imperative it is for this accommodations to be allowed.
