## Additional Exemption Information

**Some of the Exemptions listed below are applicable to motor vehicle tax bills, if you DO NOT own real estate.**

*Please note that these amounts are subject to change annually. These amounts are based off the 2022 tax rates.*

### **Total service-connected disable vets RIGL 44-3-4:**

#### **Amount of Tax Credit**

Amount off real estate assessment \$16,460, (Amount off residential tax bill **\$359.82**)

Amount off motor vehicle tax bill **\$210.00**

#### **Amount**

#### **Qualification**

Honorably discharged

Must be Totally Service Connected disabled, not just collecting 100% compensation.

Please submit a letter from the Veterans Administration stating your service connected disability evaluation, **Due date may 25<sup>th</sup>.**

### **Gold Star Parent Exemption RIGL 44-3-5 :**

#### **Amount of Tax Credit**

Amount off real estate assessment \$12,500 (Amount off residential tax bill \$273.25)

Amount off motor vehicle bill \$157.50

#### **Qualification**

Please submit letter from Veterans Administration stating you are the parents of veterans deceased during combat. **Due date may 25<sup>th</sup>.**

**Veteran's Modified Housing:**

**Amount of Tax Credit**

Amount off real estate assessment \$16,460, (Amount off residential tax bill \$359.82)

**Qualification**

Please contact the office for details, an inspection of the property is required and additional documentation may be required. **Due date may 25<sup>th</sup>.**

**Certified 100% Blind Exemption:**

**Amount of Tax Credit**

Amount off real estate assessment \$29,600 (amount off property tax bill \$647.05)

Amount off motor vehicle \$630.00

**Qualification**

No application required just letter from the department of Human Services for the Blind & Visually Impaired is required. **Due date march 15<sup>th</sup>.**

**Hardship/Infirmary Exemption RIGL 44-3-3 (16):**

\*\*\*Contact the Assessor's office **annually** to apply for this exemption, application period is January 1<sup>st</sup> thru April 15<sup>th</sup>, for the subsequent tax bill. This exemption is income based.

**Amount of Tax Credit**

Variable amount off the property tax bill.

**Qualification**

The Assessor determines income guidelines based on federal poverty guidelines annually.

This application is applied for annually since income situations can fluctuate from year to year.

**Specially Adapted Vehicles 44-34-13:**

This exemption shall apply to not more than one motor vehicle owned and registered for personal, noncommercial use.

**Amount of Tax Credit**

50% off Assessed value of vehicle

**Qualifications**

Please contact the assessor's office, they will need to do an inspection of the vehicle to determine its eligibility
