RESOLUTION AUTHORIZING THE HIRING OF SPECIAL LEGAL COUNSEL BY THE CITY COUNCIL

WHEREAS, the City Council, in order carry out its inquiries, finds it necessary to hire special legal counsel to assist it; and

WHEREAS, the City Council is desirous of conducting an inquiry into the operation, staffing, personnel, and customer and public interaction and related matters within the Office of the City Clerk; and

WHEREAS, the City Council is desirous of conducting an inquiry into the City of East Providence Administration disbursement of funds provided by the Rhode Island Commerce Corporation Washington Bridge Small Business Grant Program.

NOW THEREFORE BE IT RESOLVED AS FOLLOWS:

- 1. The City Council authorizes the expenditure of funds for the hiring of the law firm of Oliverio & Marcaccio LLP, 30 Romano Vineyard Way, Suite 109, North Kingstown, RI 02852 to assist in its inquiries.
- 2. The City Council President is authorized to execute any and all documents, including the appropriate fee agreement, necessary to retain the law firm and/or any of its principles, including Matthew Oliverio for the purpose of such inquiries.
