CHAPTER 905

AN ORDINANCE OF THE COUNCIL OF THE CITY OF EAST PROVIDENCE APPROPRIATING UP TO \$2,500,000 TOWARD THE RENOVATION OF THE EAST PROVIDENCE POLICE STATION LOCATED AT 750 WATERMAN AVENUE

THE COUNCIL OF THE CITY OF EAST PROVIDENCE HEREBY ORDAINS:

SECTION I. An appropriation not to exceed \$2,500,000 to be funded from Federal ARPA funds to be used toward the renovation of the East Providence Police Station located at 750 Waterman Avenue.

SECTION II. This ordinance shall take effect upon its second passage and all ordinances or parts of ordinances inconsistent herewith are hereby repealed.

RE: Message of Disapproval

Dear Council President Rodericks and Members of the Council,

In accordance with Article III, section 3-6(b) I am returning to the City Council Chapter 905, "An Ordinance of the Council of the City of East Providence Appropriating Up to \$2.5 million toward the renovation of the East Providence Police Station located at 750 Waterman Avenue" for the following reasons.

As the Council is well aware, the Administration recently retained JCJ Architecture on June 20, 2023 (Resolution No. 44 in the amount of \$110,000) to assess and review the current conditions and future needs of the East Providence Police Station. Per the contract with JCJ Architecture, they are required "to develop up to three conceptual design options for proposed renovations/additions to the existing facility based on the findings of the Existing Conditions Survey (ECS) and Space Summary."

The Administration is fully committed to ensuring that our command staff, police officers and civilian employees have a facility that is secure, safe and functional that will meet the needs of our members of the East Providence Police Department as well as our residents.

In fact, over the last several years, with the City Council's support and approval, we appropriated for improvements to the station, the following funds:

- Roof Replacement \$305,800
- HVAC replacement \$264,046
- Parking lot expansion and upgrades to ensure the safety of personnel and security of property \$180,438
- Men & Women's Locker rooms \$146, 688
- Access Controls \$45,294
- Mobile Shelving System \$24,888

The Administration believes that the allocation and sequestering of \$2.5 million of American Rescue Plan Act (ARPA) funds as proposed by this ordinance, is premature.

Additionally, the FY 2024 appropriations act was signed into law by Governor McKee on June 16, 2023 and includes an \$11 million appropriation for Municipal Public Safety Infrastructure projects. The funds would be used for public safety facilities infrastructure improvements. The city has the opportunity to be awarded \$1 million, which could be used for the improvements at the police station.

A more prudent and fiscally responsible course of action is to wait until the JCJ study is completed. Once completed, the Administration fully intends to engage and inform the City Council of the findings and reach a consensus to move forward.

By passing an ordinance prior to the necessary preliminary information or basic due diligence, the City has lost the necessary flexibility to use these funds, if necessary, for projects that have previously been properly vetted, undergone internal review, as well as final approval by the City Council.

Additionally, as the Council is aware, these ARPA funds have a strict timeline and by sequestering these funds through an ordinance, the City is at risk of having to return the funds and also unable to use these funds to leverage future opportunities.

Survey Questions for the League of Cities and Towns

July 27th, 2023

The FY 2024 appropriations act, 2024 H-5200 Substitute A as amended, was signed into law by Governor McKee on June 16th, 2023. The act included an appropriation of \$11 million for a Municipal Public Safety Infrastructure project within the Department of Administration (DOA). The project is financed from the State's allocation of the American Rescue Plan Act (ARPA) State Fiscal Recovery Fund (SFRF) and will be overseen by DOA's Pandemic Recovery Office (PRO). The legislative language for the project is below:

DOA - Municipal Public Safety Infrastructure. These funds shall be used to provide matching support to cities and towns to make significant public safety facilities infrastructure improvements including new construction. Funding priority shall be based on project readiness and limited to those for which the total costs exceed \$1.0 million. Matching funds to any municipality will be limited to \$5.0 million for projects that serve a regional purpose and \$1.0 million for others.

Additionally, the U.S. Department of the Treasury requires each project financed by ARPA SFRF to obligate all funds by December 31st, 2024 and fully expended by December 31st, 2026. According to U.S. Treasury, an obligation is defined as "an order placed for property or services and entering into contracts, subawards, and similar transactions that require payment."

Given these stringent obligation and expenditure timelines, as well as the legislative requirements surrounding municipal match and project readiness, PRO is engaging with the League of Cities and Towns to gain better insight into the scope of eligible projects across Rhode Island municipalities. To assist the State with the development of the grant program, please complete the below survey and return to the League of Cities & Towns by August 18th, 2023.

ELIGIBILITY

- 1. Can all facets of your municipal public safety infrastructure project be obligated (as defined above) by December 31st, 2024 and fully expended by December 31st, 2026? Please describe.
- 2. Have all other funding sources for your municipal public safety infrastructure project been identified and are they available? Please describe. (For example, does your project require your community to place a general obligation bond question on the ballot in 2024?)
