WHEREAS,	East Providence City Charter Sec. 4-13(2) requires Council approval for the acceptance of any bid for a contract of more than fifty thousand dollars (\$50,000);
WHEREAS,	East Providence City Charter Sec. 3-5(8) empowers the Mayor to negotiate contracts on behalf of the City subject to the approval of the City Council, except as otherwise provided by the Charter or State Law;
WHEREAS,	The acquisition of energy sufficient to support the operations of the government is a large budgetary item;
WHEREAS,	The State of Rhode Island, by and through its General Assembly, has enacted Rhode Island General Laws §§ 45-55-13.2; 39-3-1.1 at least in part to support municipal savings through cooperative participation in the energy market;
WHEREAS,	The City of East Providence may take advantage of municipal savings through the Rhode Island Energy Aggregation Program, which includes other Rhode Island Municipalities and works with the Rhode Island League of Cities and Towns;
WHEREAS,	Participation in such programs has no impact on participation in Net Metering Credit programs or contracts;
WHEREAS,	The City of East Providence has an approximate annual electrical load of 6,100MWHr per year and as such may realize savings in the range of sixty-thousand dollars (\$60,000) per year by participation in the program;
Wherefore,	The City Council of the City of East Providence does hereby authorize the Mayor to enter into a contract with Constellation New Energy Inc., an Exelon Company, and Power Options to participate in the Rhode Island League of Cities and Towns Rhode Island Energy Aggregation Program for a term up to December 31, 2023 for the purchase of all of the City of East Providence energy needs.
