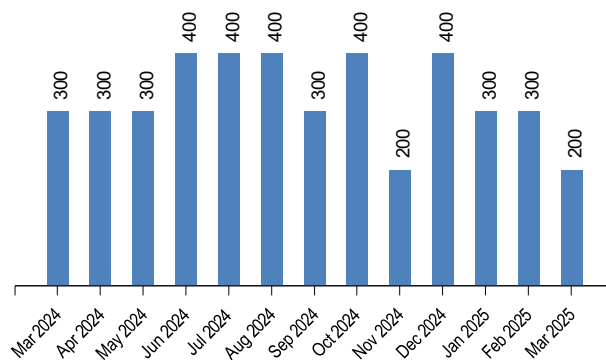

What you pay for your use. Multiply your consumption by \$0.0635 to calculate your water usage.

There is an annual fixed charge based on the size of your meter to cover administrative fees for water.

This is a surcharge added to water bills by the state of Rhode Island that has nothing to do with the City of East Providence. To calculate the Rhode Island surcharge, multiply total consumption by \$0.00218416.

Homeowners age 65 or older may be exempt. Please contact the Tax Collection Office at 435-7544 if you need to apply.

Is based on water consumption less 292 cubic feet times the rate of \$0.1315.

Meter's water use that does not go into the sewer system. This meter usage is deducted from water consumption prior to calculating the sewer use charge. Installation of a deduct meter forfeits your 292 cubic foot exemption from your sewer charge.

There is an annual fixed meter charge based on the size of your meter for administrative fees for waste water (sewer).

PAYMENT OPTIONS

Interest: Any amount not paid by the due date will be assessed an interest charge at annual rate of 12%.
