# Review of March 2024 Performance Report and Funding Recommendations by Wainwright Investment Counsel, LLC

Michael Dwyer was here from Wainwright Investment Counsel. First quarter 2024 was very good. S&P was up over 10%. This is the first time the fund balance is over 160 million. The fund total as of March is \$160,667,881. This quarter we were up 4.2% which beats all MA funds Mike is familiar with who were at 3.6%. Over five years we are up 7.3% on an annual average. It's difficult to grow this account due to negative cash flow each month, where more is paid out than put in. International Equity is a concern for Wainwright. Baring's is under performing and they will keep an eye on that. Cash is getting 5% interest rate a year so Mike isn't concerned with having cash on hand. We had a very negative April, it was down sharply but May bounced back and was very good, even better than the ending balance of March. If funds need to be raised Mike recommends taking a million from overweighed domestic equity RhumbLine Group Trust and Vangard FTSE All World. The next meeting is August 20<sup>th</sup> and Kim will not be here. Mike wanted EnTrust come to the meeting but the CEO was not available to come. If the Board would like them to come to the next meeting please let him know.

## Discussion / Action / Vote with the selection of Ice Miller LLP what are the next steps.

The clerk handed out a copy of an e-mail received by the City Solicitor from Ice Miller on May 17<sup>th</sup> with recommendations. Trustee Bellamy stated that he was able to make copies and thinks the Board needs more time to review this because it was only received the day before. Trustee DaSilva asked if these were the recommendation that Ice Miller was making already. The Chairman and Trustee Bellamy confirmed that it was. Trustee DaSilva recommended a special meeting and maybe have them come in. The Chairman stated that they were out of state but they would come in. He also suggested a ZOOM meeting. Trustee Kelley has a concern regarding some of the language in section 4 compliance on page two. It appears that it was cut and pasted but it looks like it's cut off. He thinks it would be beneficial to have Ice Miller come in person. Trustee DaSilva stated that's why we hired them so that they could look at all documents to make sure they match up. The City is having a difficult time hiring, especially police. Everything needs to be looked at. Maybe not being vested after ten years and only have retirement after twenty-five years. The whole picture needs to be looked at. Language needs to be added to shore up the pension and protect it for the future. The Chairman stated that the landscape exhibit had so many items where the Board was out of compliance, this is the reason Ice Miller

needed to be hired. Trustee DaSilva said a special meeting should be done and to have them come in. The Solicitor stated he would check his availability for a special meeting. Trustee DaSilva excused himself and left the meeting at 10:02 am.
