Review of $3^{\rm rd}$ Quarter 2025 and any funding recommendations by Wainwright Investment Counsel, LLC

Mike stated that the portfolio is doing well even though there are still cross currents in the markets and weak labor numbers. Real estate has been good for the fund in the past and Mike thinks it will get better as the interest rates go down. As of 9/30 the fund balance was \$176,099,700. 4.73% for the quarter and 9.79% year to date. Mike did note that the funds cash balance is lower than Trustee Delgado likes and he suggest drawing down funds from Vanguard FTSE All World to cover expenses. Mike also suggested that TA Associates has an open-ended fund that might be good to consider when it's time to rebalance. He asked the Board if they were interested in Mike asking them to come talk to the Board. The Chair and Trustee Delgado agreed that they would be interested in hearing what they have to offer. Mike asked when the next meeting was and the clerk stated that a vote was being taken later in the meeting and she would reach out with those dates after the meeting.

Discussion / Action / Update / Vote on a disability pension request in open session.

Retired Firefighter N. Garcia was present and wished to have his request discussed openly. Mr. Garcia requested the conversion on 9-25-23. The Solicitor let Mr. Garcia know that his doctor did not like the form that was sent to him to fill out because it said accidental on the form. The memo that the doctor sent was not sufficient for the Board to make a decision. It was explained that all cancer conversion requests are currently required to have the form filled out and returned for the Board to be able to make a decision. Also, the Solicitor wanted Mr. Garcia to know that cancer conversions were not automatic and are not tax free, this came to light while Ice Miller was working with the Board. The Solicitor, HR Director and Board all agreed that it wasn't the best form but that was the form that had been voted on to be used by the Board. The Solicitor wanted Mr. Garcia to know what his conversion amounts would be and asked if the clerk had those amounts. The clerks stated that she didn't have them but would get them. It was recommended to Mr. Garcia that he follow up with his doctor regarding the form and to think about if he still wanted to proceed with the request for a cancer conversation. Trustee DaSilva stated that a letter should be sent to Mr. Garcia stating what was talked about today, providing his current pension amount vs. what the converted amount would be if the request was granted, giving him two weeks to reply. Trustee DaSilva also ask that going forward when members

request a cancer disability conversion, they be given the amounts when they apply and told that it is not tax free.

A motion was made to give Mr. Garcia two weeks to contact his doctor, then have the clerk send a letter outlining the disability benefit amounts if awarded and asking Mr. Garcia to reply back in writing one way or the other if he wished to continue or withdraw his disability request by Trustee DaSilva and 2nd by Trustee Bellamy
