STRUCTURAL REPAIRS

Structural repairs to the Sweetland House shall include, but are not limited to, designing, installing and removing temporary shoring beams and posts; utility relocation, confirming locations and status of existing utility lines, temporary shut-off and relocation and/or replacing portions of existing utilities as needed for the installation of the structural repairs; removal and disposal of deteriorated wood and or steel beams and columns, floor joists, flooring; installing new wood blocking between existing floor joists at locations indicated on the plans; installing new wood framed beams; and installing new steel support columns on steel reinforced concrete footings. Work areas, shall be restored to original condition. Please refer to the corresponding plans which are part of this scope of work. Structural Repairs to the Sweetland House shall be installed by the Contractor at the Lump Sum price as stated in the proposal. The Bidder submits this bid proposal to perform all the work (including labor and materials) described in the solicitation (including the costs for all Allowances and

Addenda).

In areas designated for investigation, portions of the existing walls, floor and finishes, shall be removed and disposed, finish wood work, trim work, doors etc. shall be stockpiled, underlying structural elements shall be exposed for viewing and assessment by the Engineer and the City. Should the City and Engineer deem a repair necessary, the Contractor shall install the repair as detailed on the Contract Drawings. Should a repair not be deemed necessary, the Contractor shall restore the area to its original condition. Investigations and repairs, if deemed necessary shall be performed by the Contractor at the Discretionary Investigation and Bid prices as stated in the Bid Form, at each location identified for repair by the City and Engineer.
