The undersigned further understands that the unit price bids include all work including labor materials and equipment necessary to complete the project in accordance with the plans, details and specifications. This is a prevailing wage project. The contractor shall be paid for actual footage inspected and cleaned. Quantities are approximate and the contractor shall hold the unit prices bid for either additional work or reduced quantities.

All prices must be written in words and figures. In case of discrepancy, the amount shown in words will govern.

Bidder acknowledges receipt of the following addendum:

At the time of the opening of bids, the bidder shall have inspected the sites of the work to familiarize themselves with the conditions relating to the work under the contract.

Bidder hereby agrees to begin work within ten (10) days after the date of the

NOTICE TO PROCEED, unless otherwise specified or permitted by the CITY, and shall complete the work under the provisions of the Contract **by April 31, 2023.**

No Bid Bond will be required for this project. Payment requests shall be submitted on original AIA forms.

LIQUIDATED DAMAGES will be assessed at the rate of \$500.00 per day for each day beyond the contract length herein stipulated.

The undersigned bidder further agrees to pay the premiums for the Surety Bond (Performance, Labor and Materials Payment Bonds) for which said premiums are to be included in the Bid Price.
