

CITY OF EAST PROVIDENCE POLICE DEPARTMENT BOAT SLIPS, WINTERIZATION, AND REPAIRS SPECIFICATIONS REQUEST FOR PROPOSALS RFP EP23/24-05 BID OPENING THURSDAY, JANUARY 18, 2024 AT 11:00AM

INTRODUCTION

The City of East Providence's Police Department, Harbor Division is requesting proposals for 3 Patrol Boat Slips for 2024 dockage and service, along with fall winterization services and to make any repairs that are necessary for the Patrol Boats.

Prices are to be held firm for a contract term of two (2) years from date of award. Term contracts may be extended for one (1) additional term upon mutual agreement unless otherwise stated.

SCOPE OF SERVICES

I. SLIPS FOR DOCKAGE & STORAGE

- **a.** The slip sizes are (1) 30' boat slip and (2) 24' boat slips. The proposal should include the Labor rate for service, Storage winter rate for boats on trailers, storage summer rate for empty trailers.
- **b.** The 30' slip must include electricity, and all 3 slips must include water. Dockage shall be from April 1, 2024 thru November 30, 2024, Dockage facility must have security cameras in use with the ability to record a minimum of 60 days. Dockage facility must be able to provide service for:
 - i. (1) 2005 30' Boston Whaler Vigilant with T/300 HP Mercury Verado motors
 - ii. (1) 2005 21' Boston Whaler Impact with a 225 HP Mercury Verado motor
 - iii. (1) 2007 23' North Coast CC with a 225 HP Mercury Verado motor.
- **c.** Dockage facility must be able to store boats on trailers and empty trailers. Storage must be within range of the security cameras.

II. WINTERIZATION

- **a.** Propeller service, gear case oil, motor oil and filters, fuel filters, air filters, zinc packages, fuel treatment and winterization on the following;
 - i. (2) 300 HP Mercury Verado Outboard Motors
 - ii. (2) 225 HP Mercury Verado Outboard Motors

III. SHRINK WRAP

- a. (1) 27' Boston Whaler Vigilant
- **b.** (1) 23' North Coast Center Console
- c. (1) 21' Boston Whaler Impact Center Console

IV. REPAIRS

a. Any defects noted during winterization and approved by Harbormaster prior to repairs being done.
