MEASUREMENT AND PAYMENT

PART 1.00 – GENERAL

1.01 PAYMENT GENERAL

- A. Payment of the prices as set forth in the Proposal is deemed to be full compensation for all materials, labor, tools, equipment and incidentals necessary to perform the work.

1.02 PAVEMENT COLOR SEALCOATING SYSTEM (Item 1)

A. Measurement and Payment

- 1. Payment of the unit price established in the proposal for Item 1 shall be full compensation for all labor, materials, equipment required to do all work of this Contract as specified or as shown on the drawings for Item 1 or any payment under any other item, but obviously necessary to complete the Contract.
- 2. Work under this Item shall include the installation of two coats of filler, one coat of color, striping for the basketball court and tennis court (white) and pickleball court (light blue). The outside of the courts shall be red and the courts shall be green. Deck hockey area is also included and shall be coated with two coats of filler, one coat color (white) and striping (red).

1.03 PAVEMENT COLOR SEALCOATING ADDITIONAL COATS (Item 2 Add/Alt)

A. Measurement and Payment

- 1. Payment for item 2 add/alternate shall be for labor, materials, equipment required to do all work of this Contract as specified or as shown on the drawings for Item 1 or any payment under any other item, but obviously necessary to complete the Contract.
- 2. Work under this item 2 add/alternate shall be for each additional coat of acrylic color on the surfaces including red around the courts, the basketball center circle and the keys and green courts. Deck hockey shall be painted white with red lines and markings.

1.04 COURT LINE STRIPING ONLY (ITEM 3 Add/Alt)

A. Measurement and Payment

1. Payment for item 3 add/alternate shall be for labor, materials, equipment required to do all work of this Contract as specified or as shown on the drawings for Item 1 or any payment under any other item, but obviously necessary to complete the Contract.
2. Work under this item 3 add/alternate shall be for installing white line striping on top of the existing hot mix asphalt surface for the basketball courts and tennis courts (white) and 4 pickleball courts (light blue) within the court area of the tennis courts. It also includes white line striping on the deck hockey surface.

1.03 WORK BEYOND SCOPE OF CONTRACT

A. Measurement and Payment

1. Necessary work outside the scope of this contract shall be undertaken only after submittal and approval of a change order request. Payment for work completed as part of any change order shall conform to the following:
 - **LABOR** including foremen, not including superintendent, to include all insurance and fringe benefits such as social security, pension, unemployment, etc.
 - **COST OF MATERIALS** entering permanently into the work. All invoices must be submitted to the City.
 - **THE RENTAL COSTS** of all construction plant and equipment used in performing this work. Blue Book rates will be used and submitted.
 - **POWER AND CONSUMABLE SUPPLIES** for the operation of power equipment.
2. The CONTRACTOR may charge an additional 15% to the sum of the labor and material costs to cover all supervision costs, overhead, bond, profit, and other general expenses.
