MEASUREMENT AND PAYMENT

PART 1.00 – GENERAL

1.01 PAYMENT GENERAL

- A. Payment of the prices as set forth in the Proposal is deemed to be full compensation for all materials, labor, tools, equipment and incidentals necessary to perform the work.

1.02 F&I 10' BLACK CHAIN LINK FENCE (Item 1)

A. Measurement and Payment

- 1. Payment of the unit price established in the proposal for Item 1 shall be full compensation for all labor, materials, equipment required to do all work of this Contract as specified or as shown on the drawings for Item 1 or any payment under any other item, but obviously necessary to complete the Contract.
- 2. Work under this Item shall include the installation of approximately 480 linear feet of 10-foot high black vinyl chain link fence, refer to detail, including top, bottom and mid rails, around the existing tennis courts.

1.03 F&I TWO LOCKABLE 4-FOOT WIDE GATES (Item 2)

A. Measurement and Payment

- 1. Payment for item 2 shall be for labor, materials, equipment required to do all work of this Contract as specified or as shown on the drawings for Item 1 or any payment under any other item, but obviously necessary to complete the Contract.
- 2. Work under this item 2 shall be for each 4-foot wide lockable gates located as shown on the plan. Opening within the chain link fence will be larger to accommodate the gate and hardware.

1.04 F&I LOCKABLE DOUBLE 6-FOOT WIDE SWIING GATES (Item 3)

A. Measurement and Payment

1. Payment for item 3 shall be for labor, materials, equipment required to do all work of this Contract as specified or as shown on the drawings for Item 3 or any payment under any other item, but obviously necessary to complete the Contract.
2. Work under this item 3 shall be for installing two lockable 6-foot wide swing gates to produce one large opening (12-foot +).

1.05 REMOVAL AND DISPOSAL OF EXISTING FENCE (Item Add/Alt 1)

A Measurement and Payment

1. Payment for item add/alt 1 shall be for labor, materials, equipment required to do all work of this Contract as specified or as shown on the drawings for Item 1 or any payment under any other item, but obviously necessary to complete the Contract.
2. Work under this add/alt item 1 shall be for the demolition, removal, and disposal of the existing chain link fence, poles, rails, and the removal of the existing concrete pole bases.

1.06 WORK BEYOND SCOPE OF CONTRACT

A. Measurement and Payment

1. Necessary work outside the scope of this contract shall be undertaken only after submittal and approval of a change order request. Payment for work completed as part of any change order shall conform to the following:
  - **LABOR** including foremen, not including superintendent, to include all insurance and fringe benefits such as social security, pension, unemployment, etc.
  - **COST OF MATERIALS** entering permanently into the work. All invoices must be submitted to the City.
  - **THE RENTAL COSTS** of all construction plant and equipment used in performing this work. Blue Book rates will be used and submitted.
  - **POWER AND CONSUMABLE SUPPLIES** for the operation of power equipment.

2. The CONTRACTOR may charge an additional 15% to the sum of the labor and material costs to cover all supervision costs, overhead, bond, profit, and other general expenses.
